## **133. COMMUNITY LIBRARY**

Councillor C. P. Owens proposed that the Council agrees to continue to pay the Community Library Insurance for which a better policy has been sourced which offers more cover; that the Council agrees to continue to pay the Community Library Electricity bills as agreed in November 2016 and that the bills are paid directly by the Community Council as agreed in October 2016; that the Community Library moves to another Electricity Supplier to achieve better value; that the Council will review the Electricity contract annually, however, currently it appears the minimum contract period with any commercial provider are for three years but we can be informed and prepared when contract expires.

Councillor R. Davies referenced the Policy agreement that had been referred to at the previous Council meeting. Councillor C. P. Owens said the there is no policy but we have resolutions in the minutes.

Councillor S. Jones asked Council to confirm when the electricity supplier will be changed in order to achieve better values for money and will the name of the account remain as Bagillt Community Council.

Councillor C. P. Owens said this needs to be done as soon as possible and said as per a Council resolution in

November 2016 and this evening, the name will on the account will remain as Bagillt Community Council, however, he said he has noted his name is currently included on the bills and is not sure why.

The Clerk reminded Councillor. C. P. Owens this was because some months ago the current supplier wanted to discuss tariffs, smart meters etc and as the Council do not own the building, it was mutually agreed, Councillor C. P. Owens would speak to the supplier as a trustee of the Community Library and also, more recently, full access to the account was given to Councillor C. P Owens in order for him to submit metre readings and view bills.

Councillor B. T. Doleman reminded Council that the building still belongs to Flintshire County Council as the Community Asset Transfer is still ongoing and has been for the past 8 years.

Councillor K. Rush proposed that a group of Councillors could meet as soon as possible to look at the current Electricity contract and consider other suppliers and options and for Council to give authority to ask the Clerk to sign the necessary paperwork to move supplier. Councillor K. Rush offered that he would be willing to attend this meeting and also suggested Councillor C. P. Owens and the Chairwoman, Councillor A. Locker along with another Councillors who wish to attend. All information will then be reported back to the next meeting.

Councillor W. Owens added as the Library now has a charitable status, they may have better deals available to them and also asked that if Councillor K. Rush's proposal is agreed, that there are no personal come backs on any Councillors.
