## 57. PUBLIC ENQUIRY ITEM

There were no Members of the Public present who wished to comment on an agenda item, however, a Member of Public commented that Councillors should provide email addresses on the Council website.

## 58. DECLARATION OF INTERESTS

There were no declaration of interests recorded.

### **59. POLICING MATTERS**

The Chairwomen welcomed P.C. J. Harries to the meeting.

The issues raised related to parking in the village namely around the Blossoms Public House area. Councillor K. Rush reported he had received complaints from resident that travel down New Brighton Road and cannot see the oncoming traffic from the Holywell direction, which is very dangerous. Councillor C. Williams added the area needs yellow lines, however the Local Authority will not act until an accident happens.

Councillor R. Davies suggested the Police could approach the Blossoms Landlord and ask they open their small car park which may elevate the parking issues on the road.

Councillors A. Locker and T. Strong shared concerns over parking in the Manor area, in particular Coleshill Fechan, due to the narrow roads, it makes it extremely difficult for buses to pass safely and is very dangerous especially at darker times of the day.
